ARIZONA TAX CREDIT CONTRIBUTION

What is a tax credit?

Arizona tax law (ARS §43-1089.01) allows taxpayers to take a tax credit up to \$200 for individuals OR \$400 for married couples when you donate directly to a public school. Contributions made from January 1 through April 15 of a calendar year may be used as a tax credit to either the current or preceding taxable year, this could increase your refund or reduce your liability. Any unused amounts may be carried forward for not more than five consecutive taxable years. Contributions from businesses are deductible, but cannot be used to claim as a tax credit.

KAOL encourages you to participate in the Tax Credit Program and keep your tax credit local— we can assure you that 100% of your donation will go directly to the school and program of your choice.
